made available in 350 languages and sent into 211 countries. This year 87,220,897 items were printed. Each small 48-page topical
Scripture booklet costs about 4.2 cents to print.
Part VI, Line 2: Harold Mack, President, Ex-officio Director and Officer, and Marie Mack, Treasurer and Officer, have a family relationship.
Part VI, Lines 6 and 7a: World Missionary Press is organized as a non-profit religious organization with members who elect directors of the
Board.

Board. The Board seeks to provide a living, but sacrificial wage as initiated by the Founders in 1961. The same benefits are provided to all
who are eligible, including management. Comparability data is not considered relevant.
