PRODUCTION COSTS THIS PAST YEAR INCLUDED PRINTING A TOTAL OF 144,591,053 PIECES OF SCRIPTURE BOOKLETS, BIBLE STUDIES, GOD LOVES YOU COLORING BOOKS, SCRIPTURE TEXT DATEBOOKS, AND FOLDUP SCRIPTURE HANDOUTS FOR FREE DISTRIBUTION WORLDWIDE. THIS INCLUDED PRINTING 13,590,000 PIECES OF LITERATURE IN 3 FOREIGN COUNTRIES. SCRIPTURAL MATERIALS HAVE NOW BEEN MADE AVAILABLE IN 352 LANGUAGES AND 211 COUNTRIES OF THE WORLD. BECAUSE OF THE HIGH-SPEED, HIGH VOLUME OPERATION, AND USING OVER 600 VOLUNTEERS THROUGHOUT THE YEAR, THE AVERAGE COST TO PRODUCE A 48-PAGE BOOKLET WAS ONLY 4.6 CENTS.
